

Explore Acadia of the Lands and Forests Contest

Contest Rules

The Contest begins on Sunday June 26th 2016 and ends at midnight (Atlantic Daylight Time) on Sunday August 14th 2016. No purchase necessary. Limit of 1 entry per email address.

ELIGIBILITY

This Contest is open to residents of the Acadia of the Lands and Forests territory which encompasses the counties of Victoria, Restigouche and Madawaska in New Brunswick, as well as Maine's Aroostook County in the United States and the Témiscouata County in Québec. Participants must be of legal age in the province or state they reside in (21 in Maine, 19 in New Brunswick and 18 in Québec). Exclusion from participation: Core Leadership Team employees and their immediate family members and any of their representatives and associates.

One winner per sector of the Acadia of the Lands and Forests will be determined and will receive a Prize from a different sector than the one in which he or she resides. It is mandatory to indicate your city or municipality of residence and the Core Leadership Team reserves the right to verify the identity and age of the winners.
